 - > A complete day of talks with networking opportunities for all Associates the day before our Annual Conference.
 - > Waived registration fee for the duration of the full Conference.
 - > Attend talks, workshops, forums and poster presentations throughout the full Conference, excluding the Pre-Conference Events (PCE).

Key Points of the IATEFL Associate Agreement

- IATEFL will send your members from your Teaching Association who have joined as a member copies of our magazine, *IATEFL Voices*, throughout the course of their membership.
- Details of your Teaching Association's main annual event are to be sent to IATEFL Head Office via membership@iatefl.org, where it will be added to the Associate Section on the IATEFL website and the upcoming issue of *IATEFL Voices*. It is the responsibility of your Teaching Association to send these details over to IATEFL.
- Your Teaching Association will send IATEFL Head Office a copy of each issue of your Association's Newsletter.
- IATEFL will provide an opportunity for you to publicise membership of your Teaching Association and your main annual event, at its Annual Conference. This might include brochures, membership forms or posters.
- Your Teaching Association will publicise IATEFL Membership and IATEFL Events through your website and/or social media.
- Your Teaching Association will make a short announcement about IATEFL, the availability of the Associate Membership and the discount code that your members can use for the membership. It is the responsibility of your Teaching Association to send this code out to its members.
- A representative of IATEFL can attend your Teaching Association main event or main online event when possible, offering one free registration for the IATEFL representative, who is not necessarily a speaker, for this purpose.
- Each year, IATEFL will offer one free registration to a representative of your Teaching Association to attend the annual IATEFL Conference and Associates Day. This person must be available to attend the Associates Day event, which will take place the day before the main Conference begins. They will not be able to attend the Pre-Conference Event (PCE) as this event takes place at the same time as Associates Day, and therefore will not be included. This person does not necessarily need to be a speaker at the Conference.
- Your Teaching Association will be sent a copy of the IATEFL Associate Logo for your use in announcing your status as an IATEFL Associate. The IATEFL name and logo may not be used for any other purpose without consent from IATEFL. IATEFL reserves the rights to withdraw the use of the IATEFL name and logo from the Teaching Association at any time.
- Your Teaching Association will promote IATEFL Associate Individual Membership (AIM) to its current members, as well as the discount code, which is not to be shared to non-members of the Association.
